## Seeking Justice for the Minab school Massacre

On March 9, 1405 [May 29, 2025], coinciding with the onset of the terrorist attack by the U.S. military and the Zionist regime on our country Iran, we all witnessed a blatant crime in the assault on the Minab school, which resulted in the martyrdom of our sons and daughters in that incident.

According to the words of our martyred leader, the legal pursuit of these bitter crimes is one of our responsibilities in seeking justice for the pure lives lost—our martyrs.



## What is the issue?

Following the deliberate attack by the U.S. military on Minab elementary school during school hours, 120 students, 26 teachers, and a number of others present were killed. In this regard, a group of teachers and education specialists in Iran founded a campaign titled "168+1".

This campaign is the result of the Iranian educational community's sense of responsibility in the face of violations of children's security and educational environments anywhere in the world. It was formed with the aim of documented, legal, and ethical pursuit of the Minab school massacre, and to inform public opinion and international institutions of the obligations to protect children in crisis situations.

## Why was this campaign formed?

In the crime of the U.S. atomic bombing of Japan, despite clear violation of all relevant laws and despite the formation of an international case to pursue this matter, that criminal government was never convicted in any case related to this crime. In the case of the U.S. attack on an Iranian passenger plane in the Persian Gulf, this case also never resulted in a final verdict based on conviction and criminality of the United States, and the U.S. was merely obligated to pay compensation to the victims of this crime. This pattern exists in several other cases such as the Iraq war and others.

These cases and other similar incidents show us that merely documentation and careful attention to the dimensions of a crime—even in a crime as clear and obvious as an atomic attack—has not resulted in the conviction of this criminal government, and we need public pressure and the creation of a global consensus against these criminals to establish a new path in the arena of seeking justice.
